Last year we gave out 120 giant bags and this next year we want to give out at least double that.
- This next fiscal year we will be starting a new program called Sunshine Food Delivery. We will be delivering groceries to seniors who are in need but do not have the transportation to get to a food pantry. But we did start working on this program! Be looking out for more info!
- We opened our food pantry back up to East Chicago. We're thrilled and they're thrilled!

Our Programs

Food Pantry

Our food pantry is open Monday through Thursday from 11AM-2PM and on Wednesday evenings from 5PM-7PM. Our pantry serves the North Township: Hammond, East Chicago, Whiting, Griffith, Munster and Highland. This past fiscal year we served 12,801 individuals through our food pantry program. We have been blessed through so many in-kind donations and the support of Meijer grocery stores and EFSP money. Because of this we are able to give out meat, fresh produce, bread and pastries, canned goods, breakfast items, grains, etc.

Energy Assistance Program

We serve over 3,000 families every year through our energy assistance program and this year was no different with us serving 3,939. This is a very busy program and we can receive dozens of phone calls every day and see dozens of clients daily. The program starts in November of each year but people can pick up applications early so we may have 1,000 applications already in by the first few days of November.

Lawn Care Program

We served 25 low-income Hammond seniors who own their homes with twice a month lawns cutting services between May and October, done by a professional landscaping company. Many thanks to the Horseshoe Casino for the grant that pays for this! We would love to expand this program into surrounding cities but we are dependent on grant money for this program. We would also like to expand to snow removal and have been looking into it from both the financial side and finding a company to do it.
